## **Presentations from Three Guest Speakers**

The Board and YCC received three addresses:

- 1. Rudy Keller, Vice President Operations, Nav Canada. Mr. Keller discussed the staffing plan that will be followed by the operations group. Mr. Keller accepted questions from the group.
- Michel Quenneville, Consultant and Employee Benefits Specialist, Coughlin and Associates. Mr. Quenneville discussed the CATCA Life Insurance plan as well as the Critical Illness Insurance program. Michel mentioned an ad campaign that will follow over the next several months educating the membership. Mr. Quenneville accepted questions from the group.
