#### CONVENTION

The triennial CATCA convention was a success, in spite of the COVID-delayed organization, and an excellent opportunity to reconnect with our members. Thanks to the Convention Organizing Committee and volunteers who did a remarkable job in very trying circumstances.

Due to COVID considerations, we could not invite everyone we would have wanted. However, the attending members could still conduct the union's business and complete the agenda on a timely basis. The report on the convention and the record of resolutions has been delayed due to Sumeeta's departure, but it is now being finalized and will be released soon.

We are excited to announce that the next convention will be held in St John's, in 2025, for the first time in 30 years. We look forward to gathering in Newfoundland with members who attended and those who missed the convention in Quebec.

### **AIRPORT DELAYS**

There has been a lot of industry scrutiny lately regarding serious issues with traffic congestion and extensive delays for flights and passengers at major airports. When discussing the difficult circumstances with outside agencies, we have acknowledged the short-staffing situation and its origins while also stressing the positive steps we are pursuing in collaboration with NAV Canada, where possible, in hopes of alleviating the pressure this summer.

### **STAFFING**

Traffic levels continue to recover across the board beyond what was initially projected. As a result, it is putting additional pressure on controllers in units across the country and every type of unit. We are keenly aware of this situation and are continuously advocating that all steps must be taken to ensure safety is paramount and protected in every operation, every day. This means, among other things, that the company must support the health and welfare of our members through active measures during the next few months and beyond.
